Terms and Conditions

- 1. The Competition Organiser will do her best to make you up into a 3. Please ensure your cheque is for the correct total for either 1, 2 or 3 players.
- 2. No-one may enter or be entered for the competition who is not a paid up member of the Association. Should someone wish to enter who is not yet eligible for membership of the Association or has not yet joined the Association, her membership application must be received and approved by the Membership Secretary, and her subscription paid and acknowledged at least 3 days in advance of any entry request. Any such person must be eligible for membership by the date of the competition.
- 3. Anyone wishing to use a BUGGY must be medically entitled to do so. They MUST read and observe the POLICY ON THE USE OF MOTORISED BUGGIES below.
- 4. Should the competition be oversubscribed a reserve list will be held. Priority will be based on handicap and support of this event for the last 3 years. Entry Requests made after the closing date will be accepted if there are tee times available. Anyone who does not wish to remain on the reserve list must advise the Competition Organiser immediately.
- 5. In the event that an entrant has to withdraw she must advise the Competition Organiser without delay so that someone on the waiting list can be offered the opportunity to substitute.
- 6. The maximum handicap index for entries is 20.0 and the handicap allowance is 95% of course handicap.
- 7. The competition will be played under the R & A Rules of Golf.
- 8. No competitor may take more than one prize in the Silver Meeting.
- 9. Gross prizes will take precedence over net prizes.
- 10. Ties will be decided on the basis of the best score on the last 9, 6, 3, 1 holes or if unresolved on the first 6, 3, 1 holes.
- 11. Each player must have her own personal liability insurance cover.
- 12. A player is prohibited from having a Professional Golfer, Assistant Professional Golfer, Professional Caddie or a Professional Coach serve as a caddie during the tournament. Caddies may not go onto the greens.
- 13. The Competition Organisers reserve the right to alter or rearrange starting times and also alter the stipulated round of the competition should conditions make this necessary.
- 14. In the event of the competition being cancelled prior to commencement of play, all cheques will be destroyed by the Competition Organisers and all BACS payments will be refunded on receipt of entrants' bank details.
- 15. All disputes shall be settled by the Organising Committee whose decision shall be final.

POLICY ON THE USE OF MOTORISED BUGGIES

- a) Players should walk at all times unless permitted to ride by the Organising Committee.
- b) Any player needing to use a motorised buggy (hired or personal) may do so providing the host club permits its use and the player has a current Medical Certificate of Disability.
- c) All users are subject to the Host Club Policies in respect of Health and Safety and Hire conditions of Buggies.
- d) The Competition Organisers must be advised in advance and the player must make her own arrangements with the host club.
- e) The buggy may ONLY be used by the player concerned and her own equipment.
- f) The L.C.S.L.G.A. does not accept any liability from the use of such buggies and the player concerned must have appropriate Liability Insurance.

Penalty for breach of condition:

Stroke play - 2 strokes for each hole at which the breach occurred with a maximum penalty per round of 4 strokes.

Match play: At the conclusion of a hole at which the breach is discovered, the state of the match is adjusted by deducting one hole for each hole at which the breach has occurred: maximum deduction per round - Two holes.

Match play or Stroke play - In the event of a breach between the play of two holes, the penalty applies to the next hole. Use of any unauthorised form of transportation must be discontinued immediately upon discovery that a breach has occurred. Otherwise, the player is disqualified.
