1. The Competition Organiser will do her best to make you up into a 3. Please send your Online Entry Request form together with your cheque for the correct amount (£15.00 per person) for either 1, 2 or 3 players made payable to L.C.S.L.G.A and dated 12th JUNE 2026 or you may pay by Bank Transfer. 2. The Online Entry Request system will not accept entries from anyone who is not a paid up member of the Association. The member making the Online Entry must ensure that all players have paid their subscriptions.
3. Competitors who need a BUGGY for health reasons please tick the box on the Entry Request Form. They MUST read and observe the POLICY ON THE USE OF MOTORISED BUGGIES below.
4. **No refund of Entry Fees will be made after the closing date which is 28<sup>th</sup> February.**
5. Should the competition be oversubscribed a reserve list will be held. Entries made after the closing date will be accepted if there are tee times available.
6. Proof of up to date handicap index must be produced at the event before the start of the player's round. This event is qualifying for handicap purposes.
7. Any existing member whose handicap index has risen to more than 36.0 may play, but the maximum number of strokes that can be received is 95% of the Course Handicap based on a maximum handicap index of 36.0.
8. The competition will be played under the R & A Rules of Golf.

9. Ties will be decided on the basis of the best score on the last 9, 6, 3, 1 holes or if unresolved on the first 6, 3, 1 holes.
10. Each player must have her own personal liability insurance cover.
11. The Competition Organisers reserve the right to alter or rearrange starting times and also alter the stipulated round of the competition should conditions make this necessary.
12. In the event of the competition being cancelled prior to commencement of play, all cheques will be destroyed by the Competition Organisers. Please note if you paid the entry fee by BACS there may be a small delay in your entry fee being reimbursed.
13. All disputes shall be settled by the Organising Committee whose decision shall be final.

#### POLICY ON THE USE OF MOTORISED BUGGIES

- a) Any player needing to use a motorised buggy (hired or personal) for health reasons may do so providing the host club permits its use. A Medical Certificate is not required.
- b) All users are subject to the Host Club Policies in respect of Health and Safety and Hire conditions of Buggies.
- c) The Competition Organisers must be advised in advance and the player must make her own arrangements with the host club.
- d) The L.C.S.L.G.A. does not accept any liability from the use of such buggies and the player concerned must have appropriate Liability Insurance.
- e) All players who are able to walk should do so unless spare buggies are available on the day of the competition, in which case they may hire a buggy if they wish.
